2016 Vendor Application Form

The North Mountain Market will be entering its third year in 2016. The Market will be open for 20 consecutive Saturdays from June 4th to October 15th. Operating hours will be from 9:00 am until 1:00 pm, however vendors can choose to remain open for business until as late as 7:00 pm as the church will remain open to sell products from the Artisan's Co-Operative.

The benefits of being a North Mountain Market vendor include:

- an opportunity to sell your products from an authentic meeting place in the historic United Church of Canada, located at 3201 Long Point Rd in Harbourville, N.S.;
- a small, but loyal clientele which we hope will increase in number this year;
- a warm and welcoming atmosphere that occasionally features live music;
- free wi-fi access (for credit card payments); and
- a low annual fee of \$208 for the first 15 full-time vendors (otherwise \$260).
