The North Mountain Market will be entering its sixth year in 2020. The Market will be open for 20 consecutive Saturdays from May 30<sup>th</sup> to October 10<sup>th</sup>. Operating hours will be from 9:00 am until 1:00 pm, however vendors can choose to remain open for business longer as the church will remain open to sell products from the Artisan's Guild.

The benefits of being a North Mountain Market vendor include:

- an opportunity to sell your products from an authentic meeting place in the historic United Church of Canada, located at 3201 Long Point Rd in Harbourville, N.S.;
- a dedicated, local clientele plus a growing number of visiting tourists;
- a warm and welcoming atmosphere that features live music each week;
- free wi-fi access (for credit card payments); and
- a low annual fee of \$240 (\$12 per week for 20 weeks) for full time vendors
- Weekly rate or casual or part-time vendors is \$15.
